A. Downing legacy – decisions made:

- Friends of Quantock
 - ➤ Advised to re-submit an application once all necessary and relevant permissions have been received.
- Over Stowey Cricket Club/Village Hall
 - ➤ An amount of up to £5000.00 will be made available subject to various conditions being met.
- Mendip Community Transport
 - ➤ The Parish Council decided not to make funds available at this time from this legacy.
- Stowey Walking Group
 - > An amount of £100.00 will be made available.
- Over Stowey Parochial Church Council
 - ➤ An amount of £5000.00 will be made available for the project with conditions attached.
 - ➤ In addition, £1200.00 will be made available to replace the graveyard gates, again with conditions attached.

B. Highways - update from Councillor Curtis

Councillor Curtis met with Lawrence Hackling and Gary Warren to inspect and discuss the roads throughout the Parish. Assessed areas that need work:

- Agreed drain not safe at Frian
- Bincombe lane
 - 1) Hedges are the responsibility of the landowner
 - 2) Pot holes work completed
 - 3) Blocked drain to be sorted
 - 4) Culvert notes made

Halsey Cross

- 1) Pot-hole ring marked
- Additional 30 mph sign unlikely due to level of signage already apparent in the area and thinking is that the speed restriction would be ignored anyway.

C. Reply from the Forestry Commission re. Mountain bikers

Mr. Andy Harris from the Forestry Commission responded positively to the concerns communicated via the Clerk to Over Stowey Parish Council.

The Parish Council would welcome feedback following the partnership meeting due in April and would also welcome a follow up meeting at a future Parish Council meeting at which Members of the Public and Mr. Harris would be able to attend.

The Clerk will communicate this to the relevant parties and make arrangements as necessary.

D. HM Queen Elizabeth II 90th birthday Commemorative Medal for schools and councils

Information communicated to Parish Council – decision made that levels of children in Parish dictates that due to the financial commitment required in purchasing the medals, it would not be viable.
