

**OVER STOWEY CEMETERY
TABLE OF FEES AND CHARGES
EFFECTIVE FROM 1ST MARCH 2016**

1. PURCHASE OF “EXCLUSIVE RIGHT OF BURIAL” IN AN EARTHEN PLOT GRAVE.

This purchase price does not include the cost of interment or the erection of monument, “Exclusive Right of Burial” may be purchased at the time of interment or at an earlier time is wished.

- A) For the “Exclusive Right of Burial” in an earthen grave 7’x3’. £110
 - B) For the “Exclusive Right of Burial” of cremated remains
in an earthen grave 2’x2’. £44

2. COST OF INTERMENT

Regardless of whether “Exclusive Right of Burial” has or has not been granted the following charges will be made for interment.

- A) For the interment in an earthen grave of the body of a still-born child or of a child whose age at the time of death did not exceed one month. £44
 - B) For the interment in an earthen grave of the body of any other person. £137.50
 - C) For the interment of cremated remains in an earthen grave. £55

3. MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which an “Exclusive Right of Burial” has been granted.

- A) Flat stone not exceeding 6’8” x 2’8” and lying below the level of the surrounding turf. £66
- B) A headstone not exceeding 4’6” in height. £66
- C) A headstone in the Garden of Remembrance not exceeding 3’ in height and occupying a space not exceeding 2’x2’. £66
- D) A flat stone in the Garden of Remembrance not exceeding 2’x2’ and lying below the level of the turf. £33

**THE FEES STATED ABOVE INCLUDE THE FIRST INSCRIPTION
FOR EACH INSCRIPTION AFTER THE FIRST THE FEE £11**

4. BURIAL OF PERSONS NOT RESIDENT IN THE PARISH OF OVER STOWEY

The foregoing fees apply where the person to be interred, or in respect of whom the RIGHT has been granted, is or immediately before his death was an inhabitant or parishioner of the PARISH OF OVER STOWEY, or in the case of a still-born child where the parents or parent are or at the time of interment were a parishioner or inhabitant, **IN ALL OTHER CASES THE FEES WILL BE DOUBLED.**

The foregoing table of fees were fixed and adopted by the Over Stowey Parish Council acting as the Burial Authority for Over Stowey at a meeting of the said Council held on 16th July 2012 and will come into force as from 1st August 2012.

These were reviewed at a meeting on February 15th 2016 and Over Stowey Parish Council agreed that the fees will remain the same until the next review.

The date of the next review has not been set.
