5. New Items for Discussion

Adopting new Code of Conduct

Clerk explained that under the Localism Act 2012 each Town and Parish Council must adopt a code dealing with the conduct expected of members. The new regime came into effect 1 July 2012. There are a number of Codes around, 2 of which the Clerk e-mailed Parish Councillors before the meeting. The Code that Over Stowey Parish Council which to adopt is the SALC/SDC Code of Conduct. All Councillors agreed to this.
