#### **5.New Items for Discussion**

## Possibility of Installing a Defibrillator in the Village

Mrs Oates joined us tonight to discuss the possibility of installing a defibrillator in the village. Mrs Oates has recently attended an event in Nether Stowey about Resuscitation and First Aid Training. 75,000 life were saved by the use of defibrillators if they are used within the first 10 minutes. There is no need to go on a course on how to use one as the machine gives clear spoken instructions. It will not work on anyone unless the heart has stopped. A few Parishes in the local area have had them installed.

Mrs Oates has been in touch with the Managing Director of First Response about costs and the most appropriate machine,

It was mentioned that with Over Stowey being so spread out would one by the Church actually be useful or not. Within the time someone left to retrieve the machine the rapid response could be there.

Clerk will look into having an event in Over Stowey like they have just had in Nether Stowey, Clerk will contact Helen Stacey at the Quantock Medical Centre about costs.

It will also be mentioned in the February issue of the messenger for Parishioners opinions.
