New Items for Discussion

Co-Option of Mrs Rees

Due to the resignation of Cllr Morgan there is a vacancy so, in order to maintain council numbers, the Council nominated Mrs Jane Rees to join the Committee commencing from January. The vote was unanimous in favour.

SSG Hinkley Point Representative

Clerk has received an e-mail from the Communications Support Officer at Hinkley Point A Site with regards an SSG Sub Group meeting and inviting us to send a representative. Cllr Peaster is our elected voting member and will attend the meeting. He attended as many meetings as possible last year and has agreed to carry on this role for 2014

Matters Arising

Request from PCC regarding Over Stowey Churchyard

Clerk and Chair have trawled through all the minutes from the period in the Clerk's possession. They have also visited Somerset Heritage Centre where all of the older PC minutes are archived and found no mention of the PCC requesting Over Stowey Parish Council take on the maintenance of the Churchyard. Nor is there any reference to OSPC agreeing to take on the responsibility.

Clerk contacted Mr Cook at SDC and he had no documentation on the issue either but advised the Clerk to speak to the Ministry of Justice. Clerk had attempted to obtain an answer from the Ministry in time for this meeting but was unable to pin them down before Christmas.

During the conversation with SDC, it was mentioned that the PCC could apply for SDC to take on the maintenance, if they so wished.

Rook Bridge Culvert

Somerset County Council's operatives have been out and attempted to clear the culvert. Unfortunately they found that the culvert had partially collapsed and would require major works to repair. Their findings were reported back but currently they have no funds to undertake the work.

Any Other Business

Mr Hill joined us tonight to bring to the Councils attention a few potholes on the road from The Campbell Rooms to Aley Phone box. Clerk will get in touch with Highways and give them the details. Other areas that have been mentioned are, Aley Farm, Aley Lodge and Adscombe Lane.

Village Agent

Various Somerset villages have recently been appointed a Village Agent. Mrs Alison Hoare will be the person covering Over Stowey. A village agent is a point of contact for anybody needing a service or help. They can contact her and she will help them in contacting the right services. Cllr Curtis attended an event at Spaxton Village Hall to meet with Mrs Hoare and Sarah Haston, the project co-ordinator. Mrs Hoare will be covering two groups of local villages. Mrs Hoare will be joining us at our next meeting in January to explain her role in more depth.
