6. Items for Discussion:

Feedback on hedges that need cutting back

A number of hedgerows have been identified. As requested by the Highways department, the Clerk will contact the landowners to inform them that this work is required and when it will take place

• Update on signage and road markings

The road markings at Marsh Mills crossroads have been re-painted on the road coming from Over Stowey

The STOP sign is still being hit by traffic. It is recommended that a contractor who has the relevant certificate for working on the Highways is contacted with a view to moving the sign to a more suitable position. This was agreed by all members present.

• Update regarding requests for speed limits within the parish

This is being reviewed, but no further information is forthcoming from the Highways department at this time. The Clerk will continue to follow this up.

• Progress on re-levelling of Over Stowey Cemetery

Due to the recent weather conditions, it has not been possible to start this work. It was recommended that this is postponed until the spring, when the ground is not so wet. The Clerk will inform the contractor.

Progress made regarding area opposite The Cottage Inn – to increase visibility at the road junction

Cllr Barrow will contact the landowner to arrange a site visit, to agree where the fence will run and preferred materials. Once this is decided, the quotes can be requested from the agreed contractors.

• Feedback from Village Hall and Recreation Ground Committee re quotes for refurbishment of the tennis courts

The committee had not yet had their meeting; therefore, this will be deferred to the December 2019 meeting. Cllr Caswell highlighted the Hinkley Point mitigation fund and the Health and Well-Being Fund, which might be available for the project.

The Clerk will wait to hear from the committee's treasurer/secretary regarding what has been decided.

• Consider site for signs for Plainsfield (taking account of highways regulations)

It was agreed after taking into account the Highways regulations to undertake such a project (space required, distance from the highway and installation) and initiatives for the parish as a whole, that this will not be pursued at this time

• Review and adopt updated Code of Conduct

The new version does not have any new content, it has been reworded to update it and make it more reader friendly. It was agreed by all members present to adopt it.

• Update on projector/screen acquisition

The funds have been received and the items have been purchased. The Clerk will arrange for them to be available for the next planning application.

Following the VAT training that the Clerk had attended, it is not possible to reclaim the VAT if the projector were to be hired out to other groups and agencies. It was proposed that it would be more cost effective to reclaim the VAT and not charge for the use of the projector.
