## i. Update regarding proposed changes for local government reform in Somerset

Cllr Pay summarised the current situation with the business cases from <u>One Somerset</u> and <u>Stronger Somerset</u> for their unitary bids.

One Somerset are proposing a single unitary council and Stronger Somerset with two unitary councils working together. Further details can be found on their websites.

## ii. Somerset Wildlife Trust and Somerset Climate Action Network Somerset County Council £1million Climate Emergency Community Fund application

It was considered that at present as there are no clear projects suitable for the grant, an application would not be submitted. Should ideas be forthcoming, these can be reviewed at the October 2020 meeting.

## iii. Consider NALC pay increase for the Clerk and agree new level

The Clerk communicated the information received from NALC and it was agreed by all members present that the current level of SCP 10 is appropriate and that the back pay from April 1st 2020 is paid in the September pay.

## v. Update on grant application for the tennis court Refurbishment

The grant application was reviewed in July and subsequently agreed by the donations committee. A meeting will take place with the contractor week commencing October 5<sup>th</sup> 2020, to confirm works required and timescales. #### vi. Update on installation of dog waste bins

The Clerk has contacted the relevant department on several occasions, but is still awaiting a response. This will be followed up again.

It was agreed by all members present that the Parish Council object to the proposals for the following reason:

 The development has already had planning permission granted for the new entrance; therefore, it is considered that this is adequate for access to the area and that a temporary entrance is not necessary

It was also noted that with the recent installation of the bollards, the opportunities for traffic to pass safely has been seriously restricted and it is recommended by the Parish Council, that the formation of a new passing area to the east of the new entrance would be appropriate<sup>1</sup>
